I have read this agreement and understand that I have given up substantial rights by agreeing to it.

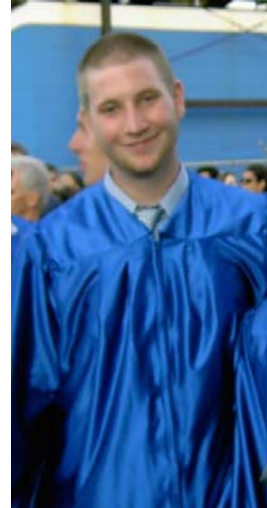
